To Whom it May Concern,

This letter provides certain representations pursuant to the SEC's Rule 15BAL-1(d)(3)(vi)(B) (the "Municipal Advisor Rule") promulgated under the Securities Exchange Act of 1934, as amended (the "Exchange Act"), regarding the participation of our independent registered municipal advisor with respect to providing advice regarding the issuance of municipal securities.

South Texas College is represented by TRB Capital Markets, LLC dba Estrada Hinojosa, ("EH"), our independent registered municipal advisor ("IRMA") registered as a municipal advisor pursuant to the Exchange Act. We have retained our IRMA to, among other things, assist us in evaluating recommendations relating to the issuance of municipal securities. We are represented by and will rely on the advice of our IRMA with respect to the evaluation of any and all recommendations you may provide relating to such matters.

Any market participants seeking to use this document for purposes of an exemption must promptly provide written disclosures indicating such to South Texas College, with a copy to our IRMA, stating that the participant is not a municipal advisor and is not subject to the fiduciary duty to municipal entities that the Exchange Act requires for municipal advisors. Additionally, we require that you provide our IRMA a copy of all correspondence that includes advice and that it be delivered to our IRMA prior to, or concurrent with delivery to either the South Texas College, but no later than the beginning of any meeting with the South Texas College or the respective component unit.
